

**Memorandum of Understanding**

This MoU is entered into 10<sup>th</sup> January 2022 by and between **Ideal Girls' College, Akampat, Imphal East, Manipur, India** and **Naorem Birahari College, Khundrakpam, Imphal East, Manipur, India**. The aforesaid institutes are here in after referred to individually as institute and collectively as institutes.

**1. Objectives of MoU:**

In order to promote Co-operation and collaboration between **Ideal Girls' College, Akampat, Imphal East, Manipur, India** and **Naorem Birahari College, Khundrakpam, Imphal East, Manipur, India** this MoU arises to carry out the following objectives:

- (a) To promote and enhance academic interest between the institutes.
- (b) To exchange the expertise's of the institutes mutually.
- (c) To promote exchange of students and research activities between the institutions.
- (d) To promote cultural exchange programs.
- (e) To encourage direct contact and co-operation's between their faculty and students in different departments particularly in the following disciplines:

i) Botany	v) Chemistry
ii) Zoology	vi) English
iii) Education	vii) Political Science.
iv) History	viii)

**2. Technical Area of Collaboration:**

Provide academic interactions by delivering special lectures at **Ideal Girls' College, Akampat, Imphal East, Manipur, India** and **Naorem Birahari College, Khundrakpam, Imphal East, Manipur, India**.

- (a) Exchange of scientific and technological information, joint publication of common results.
- (b) To exchange the visiting National and International delegates to each institutes mutually.
- (c) Identify and invite the faculty members and researchers from other institutes to participates in conference, workshops and short-term courses.

Both institutes recognize each other's legal capacity to sign this agreement and

Declare that:

**Ideal Girls' College, Akampat, Imphal East, Manipur, India** and **Naorem Birahari College, Khundrakpam, Imphal East, Manipur, India** manifest their intention to search an agreement to foster academic cooperation according to the following terms and conditions:

Article 1. **Ideal Girls' College, Akampat, Imphal East, Manipur, India** and **Naorem Birahari College, Khundrakpam, Imphal East, Manipur, India** agree to promote joint teaching, research and other academic activities as aforesaid in the objectives and technical area of collaboration for mutual benefit to both the institutes. A specific plan and agreement will be worked out and approved by the institutes before and such programs or activities can be undertaken.

Article 2. Resources for the implementation of specific programs may derive from either party or from external funds. However, this agreement does not oblige either party to expand any resources in connection with objectives herein specified unless explicitly stated otherwise in the corresponding specific agreement.

Article 3. This agreement will be effective for a period of five (5) years from the date of its signing and the renovation will be requested for the period unless otherwise specified by the signing institutions.


Article 4. This agreement does not imply any financial duty upon both the institutions.

Article 5. Either party may terminate this agreement on written notification. Such notification must be given at least six months prior to the proposed date of termination. If the present agreement is terminated, both parties must guarantee to facilitate the completion of the project and initiatives already in progress.

Article 6. Each institution appoints a coordinator for the implementation of this agreement, who will be responsible for defining and organizing the program to be undertaken and for interaction between the two institutions.


Article 7. the intellectual property right (IPR) that arise as result of joint research and collaboration activities under the agreement will be worked out on a case basis and will be consistent with officially laid down IPR policies of the two institutions.
